- 3. My process will be adequately shown or explained. I will show visitors materials, tools and works-in-progress and will discuss, and whenever possible, demonstrate my process of making art. Storyboards and/or visual aids can also be used.
- 4. Commercial reproductions of my work will be clearly and accurately labeled, identifying the work as a "reproduction."
- 5. I agree to submit **3.jpg images of my artwork (300 dpi at 6**" largest dimension) with a brief description of work and an artist Bio that will be used for web site and promotion of the event. **1** image will be selected for the brochure.
